PRIVACY NOTICE

Introduction

The European Space Agency (herein the "Agency" or "ESA") is an intergovernmental organisation established by its Convention opened for signature in Paris on 30 May 1975 having its headquarters located at 24 rue du Général Bertrand, CS 30798, 75345 Paris Cedex 07, France.

Protection of Personal Data is of great importance for ESA, which strives to ensure a high level of protection as required by the ESA Framework on Personal Data Protection (herein the "ESA PDP Framework") which applies in this field. ESA implements appropriate measures to preserve the rights of data subjects, to ensure the processing of personal data for specified and legitimate purposes, in a not excessive manner, as necessary for the purposes for which the personal data were collected or for which they are further processed, in conditions protecting confidentiality, integrity and safety of personal data and generally to implement the principles set forth in the PDP Framework, available at:

ESA PDP Framework is composed of the following elements:

- the Principles of Personal Data Protection, as adopted by ESA Council Resolution (ESA/C/CCLXVIII/Res.2 (Final)) adopted on 13 June 2017;
- the Rules of Procedure for the Data Protection Supervisory Authority, as adopted by ESA Council Resolution (ESA/C/CCLXVIII/Res.2 (Final)) adopted on 13 June 2017; and
- the Policy on Personal Data Protection adopted by Director General of ESA on 5 February 2018 and effective on 1 March 2018.

This privacy notice is intended to inform you, as data subject, about:

- the identity of the data controller and contact details of ESA Data Protection Officer ("DPO");
- the type of personal data which is collected and processed;
- the modalities of collection of personal data;
- the purpose of the collection and processing;
- the recipients (if any) to whom the personal data of the data subject shall be disclosed;
- the time-limits for storing the personal data;
- the practical modalities of exercising the rights of the data subject under the ESA PDP Framework.

This notice also enables ESA to indicate how you can provide your consent relating to the collection and further processing of your personal data hereby described, under ESA PDP Framework. This privacy notice was last updated on: 14/7/2023.

(1) Who is the Data Controller?

Your personal data mentioned in this Privacy Notice as specified below are collected and further processed to enable your participation to the ESA Education teacher training, either held online or in person (physical training event) in one of ESA's sites and all communication in relation to the specific teacher training. For these purposes only, as well as for the purposes mentioned in Article 5 of ESA Policy on Personal Data Protection, ESA is Data Controller.



ESA does not instruct any third party to conduct any web analytics, profiling, or any other processing on ESA's behalf, other than the purposes mentioned below.

ESA does not consider your personal data as an asset for sale or for commercial exploitation on behalf of ESA.

For specific organizational and logistics purposes of teacher training, such as enabling your online registration to the training or shipping you certificates, ESA will, in its role of Data Controller, share some of the collected data with specific providers (listed under disclosure section (6) in this document), contracted by ESA as Data Processors.

In addition, for the fulfilment of the purposes and objectives of the ESA Education Programme of which the teacher training is part, such as communication and outreach purposes, and to inform you about future possibilities to be engaged, the data collected by ESA may – <u>only upon your explicit consent</u> - be disclosed by ESA to Companies listed in section (6) of this document and further processed by other ESA third parties as agreed in the contract.

This Privacy Notice also enables ESA to obtain your consent relating to the collection and further processing of your personal data, under ESA PDP Framework.

The description of the collected data, the justification for their collection and processing, and the role of the parties involved is provided in detail in the sections below.

(2) What are the contact details of ESA Data Protection Officer?

(3) What kind of personal data about you are collected and further processed?

The personal data which may be collected and further processed by ESA for the purposes mentioned below are in particular:

For all teachers / educators:

- Name
- E-mail address
- Gender (with neutrality option)
- Country of residence
- Nationality

Only for the teachers/educators selected to participate in a physical training event:

- Telephone
- ID / Passport number
- Any special dietary requirements for logistics purposes (with option of not to disclose)
- Any special mobility requirements for logistics purposes (with option of not to disclose)
- Videos recorded throughout the training (only if specific consent is provided for this)
- Pictures taken throughout the training (only if specific consent is provided for this)

General data:

- School or Organisation name and address (including city, region and country)



After the participation:

- Certification
- Statistics of data (on an aggregated level only)

You are required <u>not to send</u> to the Agency any sensitive information (including information that indicate, directly or indirectly, an individual's racial or ethnic origin, political opinions, adhesion to unions, religious or philosophical beliefs, health life, sexual orientation, genetic or biometric data, criminal convictions).

(4) How are your personal data collected or further processed?

Your personal data may be collected by various means, including via:

- Direct enquiry from ESA's <u>teachers@esa.int</u> or <u>etechnologylab@esa.int</u> email;
- Online registration to the ESA Education Teacher Trainings: (educationforms.esa.int)

(5) For which purpose are your personal data collected and further processed?

Your personal data are collected and further processed for the following purposes:

5.A) For the organization of the teacher training and logistics for the physical training event:

- select the participants of the ESA Education Teacher Trainings,
- determine their eligibility to attend the ESA Education Teacher Trainings,
- gather logistical data and share it with the contractor appointed to organise and host the ESA Education Teacher Training (the contractor will do this on behalf of ESA),
- record statistics on participation in the ESA Education Teacher Trainings,
- to manage the relationship with ESA and participants of ESA Education Teacher Trainings,
- distribute educational kits to the participants,
- distribute certificates to the participants which contain the name of the participating teacher,
- gather key participation statistical data for educational research and stakeholder reporting,
- inform participating teachers (individually, through emailing list, or newsletters) about future free-of-charge education opportunities and activities, and about additional possibilities to be involved, *with option to opt out at registration*.
- create and publish outreach and promotional content and materials on the ESA Education teacher training and the ESA Education Programme in general (including its ESERO project).
 Such materials may include participant's images/photos, videos, written/audio-recorded quotes, with option to opt out for each individual participant at online registration through the dedicated consent form thereby available,
- other purposes that will be disclosed to you when such information is requested.


In addition to these purposes, the Agency may use your personal information for any of the purposes mentioned in Article 5 of the Policy on Personal Data Protection.

The following **Data Processors acting on behalf of ESA** as Data Controller (also listed in Chapter (6)) will process your personal data for the following purposes in particular:

WDOIT (Data Processor 1), the company providing ESA with the servers where online registration for the teacher training is hosted.

Data involved are: all data contained in the teacher training registration form.

ATPI (Data Processor 2), the company organising some of the teacher training events.





5.B) For the fulfilment of the purposes and objectives of the ESA Education Programme

The ESA Data processors indicated below may – *upon your explicit consent at registration* - process the following data for the following purposes related to the fulfilment of the purposes and objectives of the ESA Education Programme, of which the teacher training is part:

ESERO Office in Your Country (Data Processor 3), (see full list in Table 2 below) the organization contracted by ESA to deliver and promote the ESA school-level education programme in the ESA Member States:

i) To support ESA in the promotion of the ESA Education teacher training and the ESA Education Programme in general (including its ESERO project) in your country by creating and publishing outreach and promotional content and materials which may include participant's images, videos, written/audio recorded quotes, the latter with option to opt out through the dedicated consent form downloadable at registration.

Personal Data involved are: Photo, video, written/audio-recorded quote of participant, with option to opt out for each individual participant at registration through the dedicated consent form.

ii) To inform you - individually, through emailing list, or newsletters - about future free-of-charge education opportunities and activities, and about additional possibilities to be involved, *with option to opt out at registration*.

Personal Data involved are: full name, e-mail address, school or organisation name, school or organization type, subjects of teaching.

Third party IT tools, including Social Media

The Agency and its Data Processors do not consider your personal data as an asset for sale and, thus, do not sell your personal data to any third parties

(7) How long do we retain your personal data for?

The Agency may keep your personal data for as long as necessary for the fulfilment of the abovementioned purposes. Your Personal Data shall be deleted thereafter.

- Names, email addresses, gender (with neutrality option) and country of work (teacher/educator): Delete the data 5 years after teacher training event or if the individual asks to withdrawal consent, whichever occurs first
- Telephone, ID/Passport number: Delete 1 month after the physical training event.
- Certificate (with teacher's name): Delete the data 5 years after teacher training event or if the individual asks to withdrawal consent, whichever occurs first
- Any special dietary requirements for logistics purposes and any special mobility requirements for logistics purposes (with option of not to disclose): Delete 1 month after the physical training event.
- Names, email addresses for evaluation of the impact of Education initiatives: Delete the data 15 years after teacher training event or if the individual asks to withdrawal consent, whichever occurs first

(8) How can you erase, rectify, complete or amend your personal data?

The Agency is keen to collect and process accurate personal data and to keep it up to date.

You may request the erasure, rectification, completion or amendment of your personal data if, and to the extent that it is inaccurate or incomplete, having regard to the purposes for which they are collected and processed, or if they are processed in violation with the principles referred in ESA PDP Framework.

If you choose to make a request for the erasure of personal data, you understand and agree that you may no longer be able to participate in the ESA Summer and Autumn Teacher Workshops.

(9) What could you do in case of a data protection incident?

In case of a data protection incident, you should contact ESA DPO, as first point of contact, by sending an email to: dpo@esa.int and teachers@esa.int.

In case you wish to submit a complaint, you are required to comply with the Rules of Procedure of the Supervisory Authority set forth by ESA PDP Framework. You will be required to demonstrate that a data protection incident occurred in relation to your personal data, following a decision of the Agency or at least to justify serious reasons to believe that such incident occurred.

(10) Your consent

The processing of personal data described in this privacy notice is based on your consent.

You may provide your consent during the ESA online registration process to the teacher training by accepting this Privacy Notice (selecting 'yes' in the related checkbox).

You can withdraw such consent by requesting ESA to stop the processing. This will not affect the legitimacy of the personal data processing that took place prior to the withdrawal of user consent.



You can withdraw your consent at any time by sending an email to ESA DPO at: dpo@esa.int in copy to: teachers@esa.int.

If you choose not to give or to withdraw your consent to the collection and processing of your personal data described in this Privacy Notice (with the exceptions of your opt-out options described in Chapter 5, points i, ii, iv & v), you understand and agree that you will no longer be able to participate in the corresponding teacher training.

For those cases where your consent was not already obtained by ESA (including by other modalities) and is required under the ESA Framework on Personal Data Protection, you hereby agree with the collection and further processing of your personal data.

You will be able to withdraw your consent depending on the modality used to collect your personal data, in particular:

- by sending an email to ESA DPO at: <u>DPO@ESA.int</u> in copy to <u>teachers@esa.int</u>.

(11) Photography/audio/video

When attending the *ESA Education Teacher Trainings*, you enter an area where photography, audio and video recording may occur and you agree that your personal data (image, name, school and country of residence) are collected by, or for, ESA in accordance with the current ESA framework on the protection of personal data and applicable ESA rules.

To respect our visitors wishes, we offer visitors with the option to opt out. Therefore, **we reserve a part of the room of the event that will be excluded from recordings**.

ESA will then publish and/or distribute the content recorded to the large audience in the public interest, in particular, related to science, space and similar matters. For that, ESA will use the relevant content by, publishing social media posts, articles, images or videos of you which are considered relevant for the performance of the activity carried out by the Agency. This aims to benefit and inform the citizens of Europe and the world about the new and/or relevant projects, or missions, with regards to, mainly, education, science and space.
